Federal Food Safety Laws. Under authority of the Federal Meat, Poultry and Egg Products Inspection Acts, Food Safety and Inspection Service (FSIS) of the USDA inspects and monitors all meat, poultry and egg products sold in interstate and foreign commerce to ensure compliance with mandatory U.S. food safety standards and inspection legislation.

Federal Food Safety Laws

Generally, Food Law may be divided in two parts: (1) a basic food act, and (2) regulations. The Act itself sets out broad principles, while regulations contain detailed provisions governing the different categories of products coming under the jurisdiction of each set of regulations.

DHEC Laws and Regulations: Food Safety | SCDHEC

"Produce farm", for purposes of IC 16-42-1 through IC 16-42-4, means a person that: (1) grows, harvests, packs, or holds covered produce (as defined by 21 CFR 112) that is intended for human consumption; and (2) is subject to 21 CFR 112. The term does not include a person that is exempt under 21 CFR 112. As added by P.L.101-2018, SEC.2 Article 42.

The U.S. food processing sector is extensively regulated by state and federal agencies. Federal agencies dominate the regulatory oversight: USDA FSIS for the meat and poultry processing businesses and FDA for all other food processing businesses.
