### 2.2 The livelihoods framework

The DFID has developed a 'Sustainable Livelihood Framework' (SLF) which is one of the most widely used livelihood frameworks in development practice. The SLF was integrated in its program for development cooperation in 1997. DFID adapts a version of Chambers Conway's definition of livelihoods:
